

Notice for new personnel/Admission declaration

Membership of the Ascaro Vorsorgestiftung commences as soon as you take up your new employment. If you are 24 years old or more and were already a member of a pension scheme, you have a fundamental right to transfer your benefits. **Under Article 3 of the Swiss Vested Benefits Law the transfer of all vested benefits to the new pension scheme is obligatory.** To facilitate the transfer you can give the pay-in slip below to your former pension scheme which will arrange for the transfer. As soon as the vested benefits have been transferred, you will receive a new certificate of insurance.


